Mr. Beatty explained that the presented report had not been finalized due to delays in the return of confirmations the auditors of Moss Adams required from Commission contractors, as well as the State Controller's Office implementing based on their auditor comments to change the valuation of their investment pool of which we are a member. This late-stage change from their audit required Staff to make edits to the ACFR.

The presented draft has been reviewed by Moss Adams and is otherwise complete. The final process will be concluded after an independent quality review from an auditing partner of Moss Adams to ensure the ACFR adheres to Governmental Accounting Standards Board and Government Finance Officers Association standards. Staff is waiting on that editorial comment to complete this year's audit, however, there will be no change to the actual numbers in the report.

Mr. Beatty introduced Keith Simovic and Laurel Stevens of Moss Adams, who presented an explanation of the auditing process for the ACFR of Fiscal Year 2021. A copy of the presentation is attached and made a part of the minutes. (See Attachment A).

Chairwoman Kelley thanked the auditing team from Moss Adams for contributing to a collaborative and respectful auditing process, as well as Staff for their hard work.

Commissioner Stewart asked if it would be necessary for the Subcommittee to meet again to vote on accepting the final ACFR, as the presented report was a draft. Mr. Beatty explained that it would not be necessary to do so, as no substantive changes to the report were anticipated.

Commissioner Stewart thanked Staff and the auditing team from Moss Adams.
